NOTIFICATION

In exercise of the powers conferred by the proviso to Articles 309 of the Constitution of India, the Governor of Rajasthan hereby makes the following rules further to amend the Rajasthan Excise Subordinate Service (General Branch) Rules, 1974, namely:-

1. Short title and commencement.- (1) These rules may be called the Rajasthan Excise Subordinate Service (General Branch)(Amendment) Rules, 2017.

(2) They shall come into force with immediate effect.

2. Amendment of rule 6.- The existing proviso to clause (a) of sub-rule (1) of rule 6 of the Rajasthan Excise Subordinate Service (General Branch) Rules, 1974, hereinafter referred to as the said rules, shall be deleted.

3. Amendment of 13.- In rule 13 of said rules,-

(i) the existing provision shall be numbered as sub-rule (1); and

(ii) after the sub-rule (1), so numbered, the following new sub-rule (2) shall be added, namely:-

"(2) Notwithstanding any thing contained in sub-rule (1) a candidate for direct recruitment to the post of Excise Guard Grade II must have the following minimum standards of physical fitness, namely:-

Candidates belonging to the Scheduled Castes and Scheduled Tribes whose height and chest measurement are less by 5 cms. shall be deemed to be physically fit in case of requisite number of suitable Scheduled Castes or Scheduled Tribes, as the case may be, candidates possessing physical fitness standards as laid down above are not available.

But in case of candidates belonging to Assamese, Bhutanese, Garhwalis, Gorkhas, Kumaonis, Ladkhese, Mizo, Naga, Nepalese, Sikkimese races and those from Arunachal Pradesh, Lahul and Spiti, Meghalaya the following relaxed standards shall apply:-

Candidates failing to fulfill the above specified standards of height/chest/weight measurements shall be rejected."

4. Substitution of rule 19.- The existing rule 19 of the said rules, shall be substituted by the following, namely:-

"19. Scrutiny of Applications.- The Commission/Board/Appointing Authority, as the case may be, shall scrutinise the applications received by it and require as many candidates qualified for appointment under these rules as seem to it desirable to appear in written examination:

Provided that the decision of the Commission/Board/Appointing Authority, as the case may be, regarding the eligibility or otherwise of a candidate, shall be final."

5. Insertion of rule 20A.- After the existing rule 20 and before the existing rule 21 of the said rules following new rule 20A shall be inserted, namely:-

"20A. Selection to the post of Excise Gaurd Grade II.- (1) Notwithstanding any thing contained in these rules, selection to the post of Excise Gaurd Grade II shall be made on the basis of written examination followed by physical efficiency test as laid down below:-

(i) Written Examination-Total marks-100

(ii) Physical Efficiency Test:

(iii) Physical Efficiency Test shall be of qualifying nature.


(iv) Candidates upto three times (Category wise) of the total advertised vacancies will be called for physical efficiency test on the basis of marks obtained in written examination.

(v) Merit list shall be finally prepared, amongst the candidates who had qualified the physical efficiency test, on the basis of total marks obtained by them in written examination."

5. Amendment of Schedule.- In Schedule appended to the said rules, the existing serial number 4 and entries thereto shall be substituted by the following, namely:-
